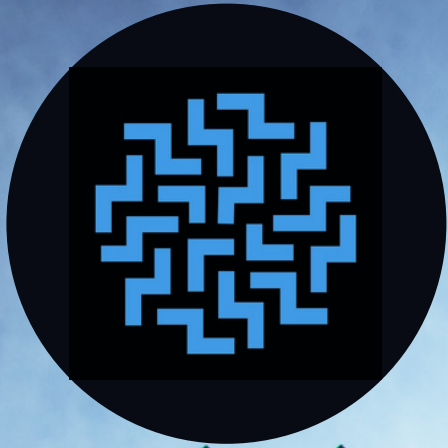

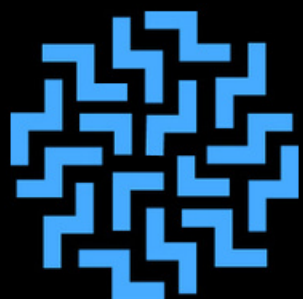

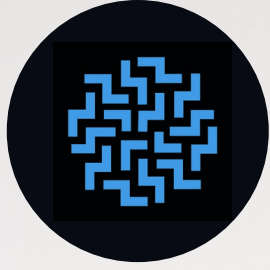
OVERVIEW

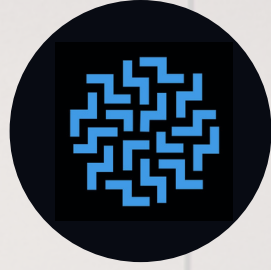

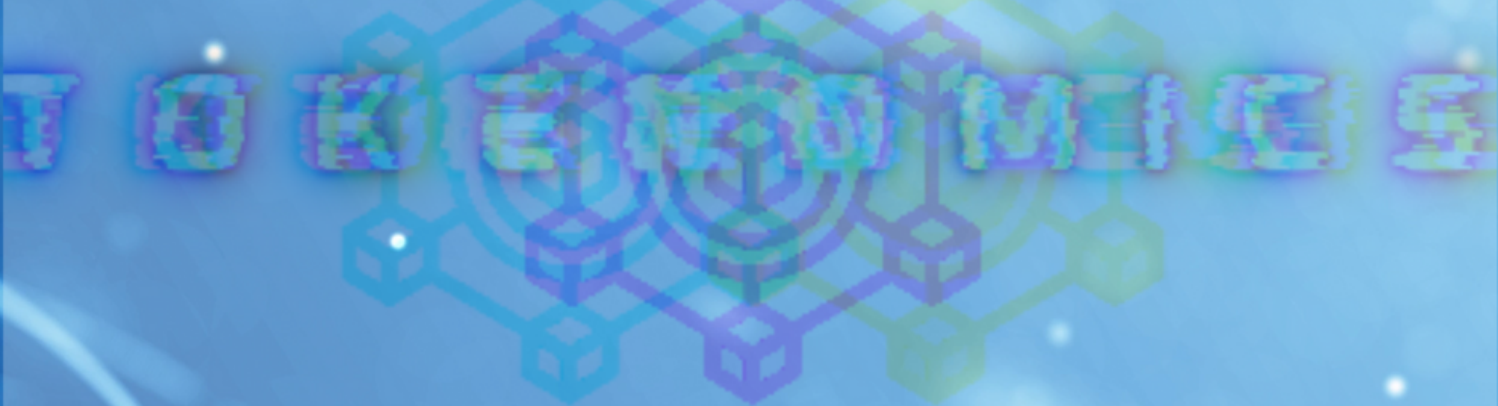

LIQUIDITY

LIQUIDITY POOLS ARE COLLECTIONS OF TOKENS MAINTAINED IN SMART CONTRACTS THAT PROVIDE LIQUIDITY IN DECENTRALIZED EXCHANGES, ATTEMPTING TO EASE THE PROBLEMS POSED BY THE INHERENT UNCERTAINTY OF SUCH SYSTEMS. OVER ONE IS A FAVORABLE LIQUIDITY RATIO; THE MORE SIGNIFICANT THE BALANCE, THE BETTER THE COMPANY'S SAFETY MARGIN TO FUND CURRENT LIABILITIES. NO ONE HAS TO WORRY ABOUT PROVIDING LIQUIDITY BECAUSE OUR PLATFORM OFFERS A SPECIFIC % OF THE TOTAL TOKEN SUPPLY TO THE LIQUIDITY POOL THAT IS LOCKED AND FILLS UP AUTOMATICALLY.
